Direct Deposit Your Tax Refund

Choose the convenient and secure way to get your tax refund — direct deposit to your CEFCU account.

With direct deposit, you get your refund faster, plus you can manage your money through CEFCU On-Line® and Mobile Banking.

To set up direct deposit or a tax payment, provide the IRS or your tax preparer with CEFCU's routing number — **271183701** — and your **10-digit account number**.

Be sure your 10-digit account number is correct — with no spaces, dashes, or special characters — in order for any transactions to process.

Tax Season & ID Theft

During tax season, scammers try all kinds of ways to get your personal information.

The IRS will not:

- Ask for your birthdate, Social Security number, or account numbers by email, text, or social media.
- Threaten you with phone calls or texts.
- Use social media to discuss tax bills or refunds.
- Call unexpectedly about a tax refund.
- Request payment without giving you a chance to question the amount owed.

Report any fake calls, texts, or emails to **phishing@irs.gov**. Be sure to include the number and a screenshot of the text or email. For tips on how to protect yourself, go to **irs.gov** and search for **tax scams**.
