

## **CEFCU® California Member Centers Youth Events Coloring Contest Official Rules**

Each Entry Has An Equal Chance Of Winning. No Purchase Necessary To Enter Or Win. A Purchase Will Not Improve Your Chance Of Winning. From all eligible entries received in accordance with these Official Rules, winners will receive one of the following prizes: Grand Prize: (1) \$250 gift card for the Coloring Contest, Runner-Up Prizes: (4) \$50 Fandango gift cards for the runner-up to be selected from all entries for both the Coloring Contest. All federal, state, and local laws and regulations apply. The Contest is open to residents of the United States who are 18 years of age and younger as of June 9, 2018. Employees, officers, and directors of CEFCU, CEFCU representatives or agents and their immediate families and persons with whom they are domiciled, its subsidiaries and affiliates, its advertising agencies, and its attorneys and consultants involved in the Contest, are not eligible to win. Void outside the 50 United States, in the District of Columbia, Florida, New York, and Rhode Island, and where prohibited, taxed, or restricted by law. Tax liability of the prize is the responsibility of the winner. The sponsor of the Contest is Citizens Equity First Credit Union (CEFCU), 5401 W. Dirksen Parkway, Peoria, IL 61607-1193.

- **1. Promotional Period:** CEFCU California Member Centers Youth Events Coloring Contest (the "Contest") begins at 10 a.m. (PT) June 9, 2018, and ends 6 p.m. (PT) June 16, 2018 (the "Promotional Period").
- **2. How To Enter:** Print and color one of the coloring sheets available at cefcu.com/events. Complete the form on the coloring sheet and enter it in one of three ways: 1. Deliver the coloring sheet to a Youth Event at one of the participating Member Centers. 2. Mail the coloring sheet to CEFCU Coloring Contest, Marketing Department, 5401 W. Dirksen Parkway, Peoria, IL 61607. 3. Complete an entry form at a participating Member Center.
- 3. Eligibility: You do not have to be a CEFCU member to enter. The Contest is open to residents of the United States who are 18 years of age and younger as of June 9, 2018. Employees, officers, and directors of CEFCU, CEFCU representatives or agents and their immediate families and persons with whom they are domiciled, its subsidiaries and affiliates, its advertising agencies, and its attorneys and consultants involved in the Contest, are not eligible to win. Participation by each entrant in the Contest constitutes agreement by the entrant's parent or guardian to these official rules. Void outside the 50 United States, in the District of Columbia, Florida, New York, and Rhode Island, and where prohibited, taxed, or restricted by law.
- **4. Drawing:** Winners will be selected in a random drawing to be held after June 16, 2018, by CEFCU, whose decision is final, in Peoria, Illinois, from among valid entries.

## 5. Conditions to Claim Prize and Notification of

**Winner:** The winner will be notified by phone or mail by September 18, 2018. The winner's parent or guardian will be required to sign an Affidavit of Eligibility and Release of Liability form ("Affidavit, Consent, and Release") provided by CEFCU as a condition of receiving the prize, which must be returned to CEFCU within five days of notification. In the event a prize winner fails to return the signed Affidavit, Consent, and Release to CEFCU within five days of notification, an alternate winner will be selected.

**6. Award of Prizes and Odds:** The odds of winning depend on the number of valid entries. From all eligible entries received in accordance with these Official Rules, winners will receive one of the following prizes: (1) \$250 gift card for the Coloring Contest, Runner-Up Prizes: (4) \$50 Fandango gift cards. The prizes are non-assignable and non-transferable. Winners are solely responsible for reporting and payment of any tax on the prize awarded. As a prize winner, you waive the right to assert as a cost of winning any prize, any and all costs of verification or travel to redeem or claim said prize, and any liability which might arise from redeeming or seeking to redeem said prize.

CEFCU reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of the Contest as solely determined by CEFCU. CEFCU reserves the right to suspend or terminate the Contest if it becomes corrupted for any reason. In such event the prize will be awarded from eligible entries received prior to the date of termination. CEFCU shall not be responsible for inadvertent, typographical, or printing errors in these Official Rules or in other materials relating to the Contest. CEFCU cannot be held responsible for any contestant's inability to successfully complete the online entry, whether due to server error or otherwise.

General Release:** Entrant acknowledges and agrees that CEFCU, its affiliates and related service organizations and their respective officers, directors, employees, agents, attorneys, and consultants are not and shall not be responsible for any costs, injuries, losses, or damages of any kind arising from or in connection with incomplete, lost, late, misdirected, or illegible entries or for failure to receive entries due to any cause whatsoever and from all claims and liability relating to their participation in the Contest and the acceptance and/or use of the prize.
